Sub: Decision of SRC in its 430<sup>th</sup> meeting held on 01<sup>st</sup> December 2023.

Sir,

The matter of Institution namely Tamilnadu Open University, Director of Technical Education Campus, Guindy, Chennai-60025 was placed in the 430<sup>th</sup> meeting of SRC held on 01<sup>st</sup> December 2023 and the SRC decided the following:-

*"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations:-*

*After careful perusal of the documents submitted by the institution in response to the SCN & representation received from the institution, the Committee decided to issue the letter of continuation of recognition granted by the NCTE to run the B.Ed. (ODL) programme by Tamilnadu Open University, Director of Technical Education Campus, Guindy, Chennai-60025 with an annual intake of 500 students for English Medium and 500 students for Tamil Medium the purpose of obtaining DEB, UGC approval only.*

*The University shall ensure the adherence of norms and standards of B.Ed. (ODL) programme particularly the following before the commencement of the academic session, until that admissions should not be made:-*

- (i) The approval for Self- Learning Material from the DEB, UGC.
- (ii) To ensure the availability of core staff at the University/Distance Education Centre.

*In view of the above the SRC directed the Regional Director, SRC to issue the letter of continuation of recognition to the institution with the instruction to comply with the above requirement within 6 months from the issue of the letter and submit compliance report to NCTE."*

In compliance with the decision of SRC-NCTE vide SRC 430<sup>th</sup> meeting held on 01<sup>st</sup> December 2023, the institution shall continue to operate on the strength of the original formal recognition granted to institution by the SRC, NCTE with instruction to comply the following conditions:-

- (i) The University/Distance Education Centre/Institution should ensure the adherence of NCTE norms and standards of B.Ed (ODL) Programme before the commencement of the academic session until then no admissions should be made.
- (ii) Approval of the Self- Learning Material (SLM) from the DEB-UGC.
- (iii) Ensuring the availability of Core Staff at the University/Distance Education Centre/Institution for B.Ed (ODL) Programme as per the NCTE norms and standards.

Therefore, the Tamilnadu Open University needs to comply the above requirements within 6 months from the date of issue of this letter and submit the compliance report to NCTE-SRC for its further process.
