The Vice-Chancellor and Chairman of the Academic Council welcomed the members to the Meeting and in his welcome address he has enumerated the developments/initiatives of the TNOU since last meeting, which are as follows:.

He has pointed out the direct supervision of University Faculty members in the Zonal Centres of TNOU, to provide quality support services to the students/learners community and establishment of public-private partnerships, by engaging established institutions, educational trust and Government Organizations. He added that steps are also being taken to initiate the field work in the new proposed Zonal Centres viz., Villupuram and Nilgiris, anticipating the G.O., as announced in the Legislative Assembly. Besides, TNOU was given the task of preparing common curricula for all the programmes offered under Distance Education by all the Universities among the State, for which also initial preparatory works have been commenced by the University.

Mentioned about the Status of 12-B obtained by TNOU and he also added that at present, TNOU is the only University in Tamil Nadu accorded approval for offering Education under Open and Distance mode from the UGC. As far as the Research Programmes, viz., M.Phil., & Ph.D., are concerned, the University has obtained in principle approval from the UGC, which are likely to be launched shortly. The Research Wing of the University has been conducting the Review Meetings regularly with the M.Phil., & Ph.D., scholars, who have enrolled earlier, to facilitate them to complete the programme at the earliest. The University has also implemented biometric system for their attendance.

He also informed about the renewal of various study centres and entering MoU with them, after scrutinizing the inspection reports by the Syndicate Sub-Committee for effective functioning of the Study Centres, under the Zonal Centres. Further, renewal will be made through online according to the performance of the centre concerned.

He also made mention about the introduction of Certificate and Diploma Online Courses by MOOCs through the SWAYAM AND SWAYAM PRABHA platforms of the Govt. of India, under the guidance of UGC & MHRD. He pointed out the Digita! Library Project of TNOU in collaboration with the Anna University and the progress of work and implementation of Online admission and payment gateway facilities since 2016-17.

TNOU has updated the curriculam for the Skill Oriented Programmes on offer, as per the qualification pack of NSDC (National Skill Development Corporation) and according to National Occupational Standards (NOS), through Community Colleges.

After the welcome address, the Academic Council proceeded with the discussion on the Agenda Items.

Thiru U. Sudhir Lodha, Member-Academic Council has proposed the following Diploma programmes:

- 1. Diploma in Industrial Safety
- 2. Diploma in Fire Safety
- 3. Diploma in Industrial Hygenic

He also informed that duration of the course would be one year with 4 days compulsory classes, Project work, Viva-voice and exam.

Dr. P. Thiyagarajan, Prof. & Director, SOCE seconded the motion which was put to vote and carried. The respective School may arrange to offer the programme after framing the syllabi and regulations from Board of Studies and with the approval of the Syndicate.

CONSIDERED and RESOLVED that the proposal to offer the aforesaid Programmes, be approved.

After the discussion of the agenda items, Prof. M. Ponnusamy, Dean, Cost Accountant of India, Chennai appreciated the initiatives taken by the University.

In his delivery of speech, among others, he has stated that the students pursuing engineering/CA/ICWAI, may simultaneously pursue M.Phil.,/Ph.D., or any other programme relevant to their field, for betterment of their career. He also has assured that he will promote the TNOU programmes to their students pursuing professional courses in their institution.

He also has made a mention about the importance of the Parliamentary Courses, conducted by the Government of India and necessity of undergoing the programme by young aspirants. Further, he has stated that the Institute of Cost Accountant is offering 100% waive off in tuition fee to the SC/ST/Minority Community.

Dr. K. Murugan, appreciated the efforts taken by the Vice-Chancellor for promotion of Research Programmes in TNOU. Also he welcomed the suggestion of Mr. Sudhir Lodha, Academic Council Member for initiating the introduction of few courses in the area of Industrial Safety.

Dr. U. Sudhir Lodha informed about the demand of graduates / diploma holders in the subject Industrial Safety. Dr. S. Subramanian, Prof. SOMS informed that they have already made efforts to introduce these programme and the Board of Studies of the School has already made the Syllabus for the same, however, there is a need of licence from T.N. Govt. for running these courses in terms of infrastructure, practical, safety etc., Dr. Sudhir Lodha assured that he will able to help TNOU in obtaining licence/approval, whatever pre-requisite; for introducing Industrial Courses, as there are huge opportunities in MNC/Abroad/Arab Countries.

He also opined that there of lot of opportunities for promoting the TNOU programmes by making awareness and campaign. He will be able to help TNOU by giving education to 500 housewives by offering funding every year through State Minority Commission.

Dr. S. Kishore, Regional Director, IGNOU, appreciated TNOU for introduction of about 8 MOOCs programmes in TNOU. Besides, he welcomed the introduction of short-terms courses.

Dr. S. Arulselvan, Professor, Journalism, Anna University has also appreciated TNOU, for introduction of the programmes in the subject film studies and the proposal of short term summer courses.

In conclusion of the Meeting, the Vice-Chancellor thanked all the Members of the Academic Council for their enthusiastic participation.
