In terms of Section 14 (1) of the NCTE Act, 1993 **Tamil Nadu Open University, Directorate of Technical Education Campus, Guindy, Chennai – 600 025, Tamilnadu** had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for **B.Ed(Distance Mode)** Course of **Two year** duration from the academic session **2004-05**.

2. On scrutiny of the application submitted by the institution, the documents attached therewith, the input received from the visiting team and upon the recommendation of the joint committee of DEC-NCTE, the Committee has noted that the University has accomplished the following tasks.

- a. Preparation of curriculum and syllabi including scheme of examination.
- b. Preparation of print and non-print courseware.
- c. Identification of study centres and schools for teaching practice.
- d. A certificate from DEC that the course material have been designed and developed as per DEC norms has been obtained.

3. Now therefore, in exercise of the powers vested under Section 14(1) of the NCTE Act, 1993 and upon consideration of the recommendation of the joint committee of DEC-NCTE, New Delhi vide its letter D.O. No. 108-15/2004/NCTE/DEC/SRC dated 4.10.2004 the Southern Regional Committee hereby grants recognition to **Tamil Nadu Open University, Directorate of Technical Education Campus, Guindy, Chennai – 600 025, Tamilnadu** to offer **B.Ed(Distance Mode)** course of **two year** duration from the academic session **2004-05** with an annual intake of **500** students, subject to fulfillment of the following:

- a) The institution will ensure that a minimum of **Six** exclusive faculty members (One Professor, One Reader, Four Lecturers) at its Headquarters duly approved by the University are in position for an intake of **500** students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case not later than one month from the date of commencement of the course.
- b) The institution shall shift to its own premises within three years from the date of recognition (in case the course is started in temporary premises).


- c) The institution shall comply with the various other norms and standards for B.Ed (Open and Distance Learning System) prescribed in the NCTE Regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the State Government, UGC, DEC etc.,

5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating body to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.

6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Southern Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act, 1993.
