## ORDER

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 Tamil Name Open University, Chennai, Tamilnadu has submitted an application to the Southern Redunal-600 Committee of NCTE for grant of recognition to Tamil Nadu Open University; Directorate of Technical Education Campus, Guindy, Chennai-600025, Tamilnadu for B.Ed(Distance Education) course of two years duration for an additional intake of 500(Five Hundred Tamil Medium) Students.

- AND WHEREAS on scrutiny of the application submitted by the institution, the 2. documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc for running the programme and has appointed duly qualified teaching staff as per NCTE norms.
- Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the 3. NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Tamil Nadu Open University, Directorate of Technical Education Campus, Guindy, Chennai-600025, Tamilnadu for conducting B.Ed(Distance Education) course of two years duration with an annual intake of 1000(Thousand) students which includes the existing intake of 500(Five Hundred English Medium) students and an additional intake of 500(Five Hundred Tamil Medium) students under clause 7(12) of Regulations dated.13.01.2006. This order of recognition shall be prospective and take effect from the date of issue of this order, subject to fulfillment of the following:
  - The university shall comply with the various other norms and standards i) prescribed in the NCTE regulations, as amended from time to time.
  - The university will ensure that Two Professors, Two Readers and Eight ii) Lecturers faculty members for an intake of 1000 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately.
  - Further, the recognition is subject to fulfillment of all such other iii) requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / bodies, State Government etc, as applicable.

- 4. The university shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- 5. The university shall maintain & update the Web-site as per provisions of NCTE Regulations.
- 6. If the university contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
